Hurricane Kitten

All across Northern Virginia residents were hunkering down in preparation for the arrival of Hurricane Isabel. The SPCA of Northern Virginia also had prepared for the arrival of Isabel by notifying our volunteers who respond to messages left on our voice mail, to check the line frequently for animal emergencies caused by the storm.

Early Thursday afternoon, as the storm quickly approached, we received a call from a woman in Springfield whose message stated that there was a small kitten crying at her door. The woman, being unfamiliar with felines, did not bring the helpless six week old kitten indoors because she had a Doberman. It is likely that she had a fear of bringing an unfamiliar animal into her home, even a hand-sized, helpless kitten begging to be let indoors.

As the rain began, the kitten left to seek shelter. Our volunteer pleaded with the caller to search behind every bush and under any obstacles to find the

kitten, as it was unlikely that an infant cat would survive the impending torrential rains and high winds. After more than an hour, the kitten was located huddled in a flowerbed. Following the instructions from our volunteer the kitten was brought indoors and placed in a bathroom.

Teaming up with another SPCA volunteer, the two rushed into action, driving through pounding rain to pick up the kitten and get it to a veterinarian. The volunteers were amazed to see the tiny baby that awaited their arrival was nothing but skin and bones.

The veterinarian gave her a thorough exam and noticed that her mouth had suffered trauma. One of her upper canine teeth had been broken in half and there were sores on the roof of her mouth. It was determined that it was most likely caused by the kitten trying to eat something inedible. Isabel weighed in at exactly one pound, had severe diarrhea, was

vomiting, and was extremely dehydrated and underweight. She was given I.V. fluids and intestinal antibiotics.

She was appropriately given the name “Isabel”, as the hurricane easily could have ended her life but instead was her savior. Weak and exhausted, she received expert care from one of our long-time foster families and made a rapid recovery. Isabel was bouncing off the walls like a normal energetic kitten before the electricity was restored.

We will never know how this beautiful little kitten ended up roaming the streets, starving, during a hurricane. We do know that Isabel already has a

wonderful family and a beautiful home waiting for her where she will live for many happy years with love, warmth and food!



Disaster Preparedness for Animals

from the Virginia Federation of Humane Societies

The best way to protect your family from the effects of a disaster is to have a disaster plan. If you are a pet owner, that plan must include your pets. Being prepared can save their lives.

- Have on hand pet carriers or crates for each pet.
- Make certain that your pet's vaccinations are current, especially for rabies. Have certificates ready to take with you if you must evacuate.
- Make sure your pet is wearing a properly fitted collar with current license and rabies tag and an identification tag. Have a leash on hand to control your pet.

Have in readiness the following supplies:

- Food and water bowls
- Ample dry pet food in waterproof containers
- Ample supply of special medications
- Litter and litter pans for cats
- Newspapers, towels, bags for disposal of pet wastes, cleaners and disinfectants
- A current photo of each pet.
- This is especially helpful for identifying your pet if you should become separated.

Leaving your pet at home alone will place your animal at greater risk for injury or loss. However, if you must leave the pets behind, take the following precautions:

- Prepare an area for your pet inside, such as bathrooms and utility rooms, well away from windows.
- Do not confine cats and dogs in the same area, even if normally they are friendly.
- Make sure all pets are wearing well-fitted collars with proper identification
- Leave enough dry food for at least three days in sturdy, non-spillable containers. Water should be left in clean, sturdy containers that will not tip over
- Place notices on doors advising what pets are in the house and where they are located
- Hang leashes where they can readily be found
- Provide a telephone number or location where you can be reached and the name and number of your vet.



Tiny Packages Of Curiosity, Love & Hope!

I've been fostering for the SPCA of Northern Virginia for 1-1/2 years now. It has been a joyful, gratifying, and at times humbling, experience. I don't have children of my own, but have been a "Mother" many times over now.

Rescue organizations like SPCA NOVA do not have a shelter. We rely exclusively on the kindness of ordinary people who are willing to temporarily open their homes to cats and kittens waiting for adoption. The biggest problem is that there are more kittens born each year than rescue groups can care for and find homes. Any kittens not rescued become part of the feral cat population or, worse, die from injury, disease or starvation.

As a foster mom to kittens, I'll be asked to take a group of these babies into my home. They start out afraid and sometimes sick. My job is to help them get strong and healthy, comfortable and friendly with people, and care for them until adopted into a home where they can spend their lives in safety and love. The first order of business is to have the kittens seen by one of the veterinarians with whom we work. They get a checkup, are tested for several feline diseases, and are given vaccinations.

The most desperate kittens we rescue are "orphaned" kittens that have been separated from their mother before they are weaned. This happens for various reasons. Sometimes the mother cat is killed, or abandons them herself, or people "dispose" of them because their unspayed female cat gave birth to kittens they didn't want. I've taken care of many of these "orphaned" kittens

myself, but only after they are bottle fed and nursed to health by our neonatal kitten specialist, Susan, who focuses exclusively on "orphaned" kittens.

One such litter was dubbed "Susan's Miracle Kittens" - a menagerie of 7 kittens of different shapes, sizes, and colors! It is truly a miracle that these little ones survived. At only one or two days old, they were found in a plastic bag inside a trash dumpster. One had already died and the other seven were rushed to Susan's care. After several months of neonatal care, many trips to the vet, and being placed in foster homes, all have been adopted.

The challenges of fostering kittens can be great. Some kittens are tame and easy to care for from the start. But others require patience to get them from hissing and growling to being able to accept love and affection. As much as I love the easy ones, the challenging ones can be the most rewarding. The first time they come out of their huddle in the corner to play with a toy or investigate something is a major accomplishment. The first look of affection in their eyes warms my heart. When they are comfortable enough to walk on me like a piece of furniture, I know they are on their way. When they run to the door when I open it, holding on to my pant legs and socks, I know they are there!

Please adopt a kitten, accept what they can offer, and give them a home for the rest of their lives. Or at the very least consider becoming a foster parent!



On Patrol . . .



The SPCA of Northern Virginia is the only all-volunteer, non-profit rescue organization in Northern Virginia whose court appointed licensed Humane Investigators enforce laws relating to animal cruelty. They generously volunteer their time to confront cruelty and indifference every day. The story of one of our more recent cases follows:

"Lucy, I'm Home!"

When the Husky mix was a puppy, she was little and fluffy and cute, and the children loved to play with her. They named her Sugar. As she grew, though, the children became tired of Sugar, and soon she was banished to the yard, and

forgotten. The family tied her outside a garage, on a short chain that allowed her only a few feet of space in which to eat, sleep, and eliminate. When it was time to feed her, they opened a can of dog food and threw it at her. Winter and summer, month after month, Sugar was outside in her tiny space without shelter or companionship. Neglected and alone, she grew despondent.

Her plight was not unnoticed, however. In June of 2003, the SPCA Humane Investigators received a call about a dog tied outside without shelter. When the Humane Investigators arrived at the home in Great Falls, they were appalled at the sight of the dog. Matted, flea and tick infested, and caked with feces, urine and mud, Sugar barely acknowledged the arrival of the two women who were to be her saviors. Within seconds, both Humane Investigators decided that the pitiful animal before them needed to be removed immediately.

Her indifferent caretakers relinquished Sugar without a backward glance, and she was taken to a vet that day. At 46 lbs, she was grossly underweight, but amazingly, otherwise healthy. After routine

vaccinations, spaying, and much-needed grooming, Sugar was ready to join the pool of adoptable SPCA dogs.

The first thing the SPCA did was change her name to Snowy. Unlike many abused dogs, Snowy didn't cower when approached, but she seemed bewildered that she was in a safe, clean place with people who petted her and spoke nicely to her. Led by Lisa Reid, the SPCA dog trainer, the SPCA dog volunteers began to rebuild Snowy's trust in people, and lift her from her depression.

On July 12, 2003 Brian and Heidi Murphy came to the SPCA Adoption Day to see another dog. Once there, though, the Murphy's were intrigued by the beautiful white Snowy, whose coat now lived up to her name. They applied to adopt her that day, and took her home as soon as their home check was approved.

Snowy, now named Lucy (after Lucille Ball), shortly became a much-cherished member of the Murphy family. When Brian comes home, he calls out "Lucy, I'm home!" In the space of 2 months, the dog that the Humane Investigators called "the worst case of neglect" they'd ever seen has found her way from hell to heaven on earth.

At this time of year, pregnant cats and mom cats with kittens are among our top priorities, as well as cats that are sick and injured. When we heard about two cats, both tortoiseshells, one very pregnant and the other severely weak and malnourished, I knew we couldn't turn them away.

A kind young woman named Jessica had been feeding a friendly stray cat, which she named Cali, for a couple of months. When she noticed the cat was putting on a lot of weight, she realized Cali must be pregnant. At about that time, she noticed another cat that began showing up at Cali's feeding time. This cat, who she named Twiggy, alarmed her because she was crying as if asking for help, and the fact that she was skin and bones made Jessica fear that she might be near death. Immediately Jessica began checking around to see if anyone could help her with these cats. She called the local animal shelter only to be informed that, yes, she could bring the cats to them but that under the circumstances they would probably be euthanized. Jessica knew there must be a better option for these two friendly cats so she contacted the SPCA of

Northern Virginia. While we didn't have any foster homes available to take them in, we knew they desperately needed our help. So, we got the ball rolling by having Jessica bring them to one of our vets. The minute I saw these cats I knew we had made the right decision in offering assistance. Both cats are as sweet as can be. It just breaks your heart that they could end up abandoned like this. My biggest fear, when looking at Twiggy, was that she might have a terminal illness. The vet had a very difficult time drawing any blood from Twiggy for testing of feline illnesses; she was so malnourished and dehydrated that they had a hard time finding a vein that could deliver any

blood. She weighed in at only 4 1/2 pounds and was estimated to be about two years old. The normal weight for an average sized female adult cat would be about 8 pounds.

Finally, they were able to draw blood and run the necessary tests. Happily, Twiggy tested negative for any feline diseases. Oh, a BIG sigh of relief!


Twiggy still has a long road ahead of her. After a week of care at the animal hospital to ensure she was eating and getting enough fluids, we were able to move her into a foster home with an experienced volunteer who is also a nurse. We needed to

give Twiggy a couple of weeks to eat, in order to regain her strength, and are happy to report that she is recovering nicely and will be available for adoption soon.

Cali, on the other hand, appeared to be very healthy and at a good weight. She tested negative for those dreaded diseases, feline leukemia and feline AIDs, had a good heart rate, clear eyes, and no signs of any illness. The vet told us she was due to have her kittens any day. At this point I began racking my brain to figure out who could foster a pregnant, soon-to-be mom, cat. I contacted one of our long time volunteers, Kristi, who didn't hesitate to say she would take Cali. With six boys of her own, feline boys that is, she knew she could handle just one more cat...even if she was about to deliver kittens! And, kittens she did! A couple of days later, Cali gave birth to five babies. Cali has proven to be a very attentive and caring mother and is such a beautiful feline we have taken to calling her Princess Cali.
